CONSIGNOR TERMS AND CONDITIONS

The following Terms and Conditions as amended by any posted notices or announcements by the SLA, constitute the entire agreement between Suri Llama Association on one hand and Ancient Treasure Sale Consignors on the other hand.

1. Warranties

All warranties are strictly between consignor and buyer.

Each consignor agrees to provide full reproductive guarantees.

- a. Maidens are guaranteed capable of becoming pregnant by three years of age.
- b. Each pregnant female will sell guaranteed to have a live cria. Any consigned female selling as pregnant must be verified as pregnant by a DVM not less than 30 days prior to the sale.
- c. A proven female/male will be considered fertile.
- d. A young male is guaranteed to be anatomically correct and must be fertile by four years of age. As part of the health exam, each consigned male must be checked and certified by a DVM to have both testicles present.

2. Terms/Financing

All consignment animals will be sold as cash sales unless consignor agrees to offer Financing, which will be defined as:

34% at time of sale (10% of which is paid to the SLA),

33% due 6 months from date of sale,

33% due 12 months from date of sale.

Purchaser will be required to insure their purchase with either Prairie States Insurance Agency or Wilkins' Livestock Insurers with seller as Loss Payee. All terms and payment schedules will be arranged by and between the consignor and purchaser only. SLA will release papers only when notified by consignor that payment has been made in full.

3. Consignment Fees

All consignors agree to pay a \$1,000.00 consignment fee. This fee includes pre-sale promotion, a listing in the sale catalog, listing on the website, stalling and bedding at the sale facility, and keuring fees. Make all checks payable to SLA. Consignor agrees that, once accepted, this entry will be reserved for the Ancient Treasure Sale. In the event it is sold prior to the sale, consignor will pay SLA 10% of the selling price in addition to the entry fee. A \$500.00 fee will be charged if consignment is withdrawn from the Sale for reasons other than as certified by a veterinarian. No substitutions will be allowed without prior approval from Sale Management.

4. Commissions

Consignor agrees to pay SLA 10% of the amount of the highest bid received for each consignment whether they sell the llama or exercise the option to have the last bid and buy back the llama. SLA will deduct that selling fee from the proceeds of the sale when making payment.

A minimum commission of \$500.00 will be charged on any lot selling for less than \$5,000. The auctioneer will accept a minimum opening bid of \$1,000.00. If any llama fails to receive an opening bid of \$1,000.00 it will be

considered a no sale, and the minimum commission of \$500.00 will be charged. Consignments will sell in the same order as they are listed in the catalog. The consignor is to furnish the buyer with a halter and lead.

5. Keuring & Registration

Each consignment animal must be keured and registered as suri by the SLA no later than May 15, 2007. (For more information on a keuring near you, contact the SLA office at 715-852-1054, an SLA board member, or check the keuring calendar at www.surillama.com.)

SLA and ILR registration certificates must be signed by the legal owner or legal agent, and given to sale management prior to the auction.

Any crias sold at dam's side require a signed ILR registration application, or ILR certificate.

6. Health

All consignments must be free of disease and verified healthy by a DVM. Llamas must come with certification that they are not persistently infected BVD carriers, and meet the Colorado Health Requirements for transport inter or intra state.

7. Arrival

All consignment animals must arrive and be checked in at the sale facility in Estes Park, Colorado no later than 4PM on May 31st, 2007.

8. Auctioneer

Consignor agrees that Auctioneer Darrell Anderson has final word on all sales and will be the decider if there is any dispute among any parties involved regarding the sale. All sales constitute a contract between the buyer and seller of each animal sold. SLA assumes no responsibility, legal or otherwise, in regard to the sale contract. The highest bidder will be the buyer.

9. Grooming & Care

All consignments may be rinsed and thoroughly picked free of debris, but any shampooing, brushing, or use of topical fiber products is forbidden. Toenails should be trimmed and suri llama presented as neatly as possible.

It is the consignor's responsibility to feed and water their own llamas at the sale site and to bring and provide adequate hay and grain for each llama consigned to the sale. All sale animals must be halter and lead broken, with the exception of crias under 3 months.

10. Donations

Up to five donation females may be included in the sale. Proceeds from these lots will directly benefit you by building the SLA National Marketing Fund.

11. Male Consignments

There will be a limited number of suri males allotted to the sale. Those farms donating a female for the SLA National Marketing Fund will get first choice to consign a male. If donating farms do not exercise that option, remaining male lots will be chosen by lottery.

I hereby authorize SLA to accept payment for my entries at the sale and understand that SLA is under no responsibility to pay me for my entries until such time as the buyer has made satisfactory payment to them. Registration papers will be held by SLA until the buyer's check clears the bank, whereupon papers will be sent directly to the buyer. The consignors will be paid by check, less commission, upon buyer's check clearing the bank. All liability for statements made in the sale catalog rest with the consignor. Please provide accurate and concise catalog statements.

Security for the consignments will be provided at the conference site. The sale management assumes no liability for loss or injury due to theft, mysterious disappearance, sickness, improper handling or act of God. The consignor agrees to hold SLA, SLA Board Members and their families harmless from damages in the event that unusual or unforeseen circumstances result in the change of location, change of time or date, or cancellation of

similar modification of this sale. Any dispute shall be resolved according to Colorado law. Any blemishes, unsoundness, defects or irregularities of any kind must be declared and the auctioneer is hereby authorized to announce all known problems and all written guarantees. The sale management reserves the right to reject any llama that in their judgment is not up to the standard of the sale.

I agree to have absolute and complete title to all llamas entered, and I have read, understand and agree to all conditions of this sale as set forth in this contract. I do further swear that all information furnished regarding these entries is true and correct to the best of my knowledge.
